Texas Fair Debt Collection Practices Act § 392.101. BOND REQUIREMENT. (a) A third-party debt collector or credit bureau may not engage in debt collection unless the third-party debt collector or credit bureau has obtained a surety bond issued by a surety company authorized to do business in this state as prescribed by this section.

## **Texas Fair Debt Collection Practices Act**

If you agreed to pay "collection costs," the agency can add reasonable charges such as attorney fees, court costs, or credit reports. If the agency is collecting
