Thus, from the legal point of view, the treaty-making power is one of the essential elements of international legal personality. In principle, only sovereign States have been qualified as entities which have full international legal personality. But as international law

Article II, § 2. Much like the treaty-making power, the President's power to appoint various public officers within and without the executive branch is contingent upon the "advice and consent of the Senate." Unlike in the treaty-making context, however, only a simple majority vote is required, not a supermajority.
